22nd January, 2025

The fifth Project Meeting for the Sport T-Index project took place in Faro, Portugal on the 22nd of January 2025. Project partner <u>Federação Portuguesa de Natação (FPN)</u> hosted this meeting. The consortium (SIGA Europe, EFDN, UCLM, IOTC, VUB, ISG, FEDAS, EPSI, FPN, EMCA and ICSSS) met to discuss the results and the progress within the project.



As always, representatives from each participating entity presented updates on the progress of their respective tasks, sharing insights into achievements, challenges faced, and potential areas for improvement. A key component of the meeting's agenda, the partners reviewed KPI's and the preparation for the launch of the Sport T-Index. What is the **Sport Transparency Index?**

- The Sport Transparency Index is a legacy project led by the Sport Integrity Global Alliance (SIGA) that includes 11 other full p artners and is part funded by the EU Erasmus+ programme. It benchmarks all levels of professional Sport Stakeholders, including clubs, leagues, and governing bodies, using a universal and validated 15 indicator frameworks to evaluate Transparency, Good Governance and Integrity at all levels of European Sport.
- The Sport Transparency Index is a pioneering initiative that addresses Transparency and Good Governance in Sport. Applying a rob ust methodology to externally evaluate all organizations this project will effectively create the means to benchmark European Sport in this regard and then make the result s freely available in the form of an Index. It combines this benchmarking with practical solutions to enable all Stakeholders to enhance their Transparency and Integrity le vel s to help facilitate positive change, irrespective of an Organisation's size, resource levels or governance related staff core competencies and experience.
- The Sport Transparency Index externally and objectively evaluates European
 Sport Organisations to establish their score and uses this information to populate the Index which will be a free to access online database released on June 18th for all interested stakeholders.

The launch event will include:

- High level Speakers from within the Sport Industry
- Introduction of the universal 15 indicator evaluation framework
- Public unveiling of the online Index with initial evaluation results of European Sport Organisations
- Opportunities to connect with leaders and change makers in European sport
